KRL CHARGES FOR USE, NON-USE AND DETENTION ON HEAVY CAPACITY OR SPECIAL TYPE FLAT CAR APPLICATION

- 1. Charges assessed under this item will accrue to KRL and are assigned and payable to Kasgro Rail Lines, 320 East Cherry St., New Castle, PA 16102.
- 2. The use or detention charges will apply on KRL cars when these cars are furnished for use in line-haul or switching service for all carriers.
- 3. Charges assessed under this item will be in addition to any other charges, including normal demurrage charges..
- 4. These charges will apply at or between all stations in the United States, and/or Canada and/or Mexico.
- If a KRL car is not listed in this item but is listed in the HEAVY DUTY AND SPECIAL FLAT CAR section of Tariff RER 6413 series, the use charge will be that provided for Rate Group H. Also, the additional detention and non-use Rate Group H charges will apply to the unlisted car.

EXCEPTIONS

EXCEPTION A - KRL will be responsible to bill and collect use and/or origin detention charges directly from Vogt Power, Sapulpa, OK, when shipped for their account.

EXCEPTION B - Use and/or origin detention charges will not apply on KRL 832001 and KRL 832002 when used in the service of or for the account of Davenport Mammoet, Rosharon, TX.

EXECPTION C- KRL 16450 and KRL 163200-163201 carries a daily rate of \$1,000 per day from date of placement or order date, whichever occurs last, until the car is released empty at destination. The daily rate will be billed directly by Kasgro Rail Car Management to user.

EXCEPTION D - KRL will be responsible to bill and collect use and/or origin detention charges directly from Nooter/Eriksen, St. Louis, MO, when shipped for their account.

EXCEPTION E - KRL will be responsible to bill and collect use and/or origin detention charges directly from Heavy Transport, Inc., when shipped for their account.

EXCEPTION F - KRL will be responsible to bill and collect use and/or origin detention charges on shipments made at Waukesha Electric, Waukesha, WI.

DETENTION CHARGES

- A. When KRL cars are held, detention charges (in dollars per car) will be assessed for each 24-hour period, or fraction thereof, after the first 0001-hour after placement, or after notification if car is held enroute.
- B. Placement is defined as follows:
 - 1. ACTUAL When a car is placed in an accessible position for loading or unloading, or at a point designated by the consignor or consignee.
 - 2. CONSTRUCTIVE When a car cannot be actually placed because of any condition attributable to the consignor or consignee and the car is held on railroad tracks.

NON-USE CHARGE

A. When a KRL car has been ordered and shipper is notified by carrier representative of car number assigned, and car is enroute to assignee, and the car order is subsequently cancelled or postponed, shipper ordering car will be assessed the non-use Rate Group charge for car ordered.
