What is Railinc?

Railinc is the largest, single source of real-time, accurate interline rail data for the North American railroad system. We serve many types of customers with our information technology solutions that solve specific logistics challenges, improve processes, and create a ripple effect of efficiencies across the entire value chain. Railinc is a subsidiary of the Association of American Railroads (AAR).

LOGGING IN

How do I log into Railinc.com?

Click the **Customer Login** link at the top right of the page. Follow the prompts to login with your Single Sign-On (SSO) username and password.

Can I use my Single Sign-On (SSO) username and password with the new website?

Yes.

I forgot my password.

Click the **Customer Login** link at the top right of the Railinc.com home page. From the Account Access page, select the **Need help signing in?** link. Reset your password by entering your user id in the **User ID** field and then click the **Forgot Password?** link. This starts the password reset process. Select **Start Password Recovery**. You'll receive an email with a link to continue the password reset process. In the email, select the **Click here to continue the password reset process** link. Enter a new password in the **New Password** and **Confirm Password** fields. Your password must meet the requirements listed at the top of the page. Select **Submit**. Once you have submitted a password that meets the password requirements, you'll receive a confirmation message and an email confirming your password has been changed.

How do I set up a login for Railinc.com?

Railinc requires an [AAR-assigned](#) reporting Mark (ABCX) or a Railinc-assigned alphanumeric identifier to access many of its systems. Companies that do not have an assigned Company ID must request one through the [Onboarding Application](#). This identifier is unique and, once established, may be used to access other Railinc systems. Once you have a Mark or Company ID, register by clicking the **Customer Login** link at the top right of the Home page. Then select **Create an account now** link and follow the prompts to register for the SSO User ID.

How do I request access to Railinc Products?

Once you have an AAR-assigned reporting mark or Railinc-assigned alphanumeric identifier, log into Railinc.com to open the **Launch Pad**. In the **My Profile** section, choose the **View/Request Permissions** link to request access to available products, or contact your company administrator.

Railinc's [Interline Settlement System® \(ISS\)](#) is the only centralized process to negotiate and agree upon the sharing of revenue generated for a movement when two or more railroads are involved in a shipment's route. ISS is the method by which the rail industry settles interline freight revenues via Electronic Data Interchange (EDI).
