Umler® Adding Equipment


This Quick Guide shows how to add equipment to Umler.

The Company Administrator controls each user's access to add, modify, or delete equipment in the Umler system. The user managing the equipment must have "Umler Access for Maintenance" and must be granted Equipment Rights in Umler.

Use this procedure to add one or more pieces of new equipment:

- 1. Sign in to Launch Pad and navigate to Umler.
- 2. From the Umler menu bar, select Maintenance > Add/Change/Delete > Add Equipment.



- 3. On the Add Equipment screen, enter one or more **Equipment ID(s)**, select the **Equipment Group**, and for articulated equipment select the **Connected Unit Count**. Equipment IDs can be entered as specific values separated by commas, or as a range of values separated by a hyphen, or as a combination of both comma-separated values and ranges (e.g., RAIL401, RAIL404, RAIL500-RAIL599).
- 4. Click **Validate** to verify that the Equipment ID(s) entered do not receive any red error messages indicating that you entered an already active ID.
 - For equipment that has been used previously, a yellow message will inform you that you can proceed to submit the form and add the equipment back as new.
- Once you receive the green Validation Succeeded message, click Submit.
- Next, enter the fields on the element entry page. Mandatory fields have a red dot in the Flag column and must be entered to continue.



Validation succeeded. Click the Submit button to go to the next screen.

- 7. Then click **Validate**. The system checks all applicable business rules and marks invalid or missing fields with red errors.
 - Elements may become mandatory based on your equipment data.
 - If you need to save your progress without submitting incomplete or erroneous data to the system, click **Suspend**. Resume adding equipment from the **Maintenance** > **Suspended Work** menu at a later time.
- 8. Once you receive the green **Validation Successful** message, click **Submit** for a confirmation that the equipment has been added to the system in **Pre-Registered** status.
